Amendments to the enate Rules of Procedures

16. Record of Voting

When a vote is taken in the Senate, any member may require that the numbers, or that the member of All Senators, including Ex Officio members, have own vote, be recorded in the minutes.

III. Voting

r16a. Record of Voting Rights
All Senators, including Ex Officio members, have
full voting rights. Voting rights are limited to
those Senators present at the time of the vote.
Proxy votes are not permissible. In the case of a
tie, the Chair has a casting vote.

III. COMMITTEE OF THE WHOLE

18. Definition

The Senate may at any time form itself into a committee of the whole body. The purpose of this procedure is to allow less formal discussion of a complex or controversial issue which, nevertheless, requires some action to be taken.

19. Procedure

A committee of the whole is ordinarily appointed by a motion "that the motion (designated by the substantive issue or the names of the movers) be considered in the committee of the whole with (name of person) in the chair".

A motion made in committee of the whole need not be seconded, and the rule limiting the number of times a member may speak shall be withheld except that no member may speakore than once to any question until every other member choosing to speak shall have spoken.

Committee of the whole is terminated by passing a motion "that the committee the whole now rise and report". The person whacted as chair of the committee of the whole then reports to Senate, usually in the form of a motion "that Senate concur with the decisions made in the committee of the whole, nameperg-1(co)-aur n

> In circumstances where electronic voting is necessary, the Nominating Committee shall present a slate of nomineets the Senate prior to the date scheduled for the vote. Nominations, in addition to those presented by the Nominating Committee, may be received electronically, or in writing, by a date specified by the Secretary of the Senate, and must be accompanied by written evidence that the nominee is willing to serve along with the name of 3 members of Senate. If there are additional nominations, the Secretary of the Senate shall transmit to all Senators electronically a ballot containing the biographical information or other comments (up to a limit of 75 words) of the nominee(s). In order to be valid, ballots shall be returned to the Secretary of the Senate on or before a specified date. The result of the vote shall be transmitted to the Senate.
